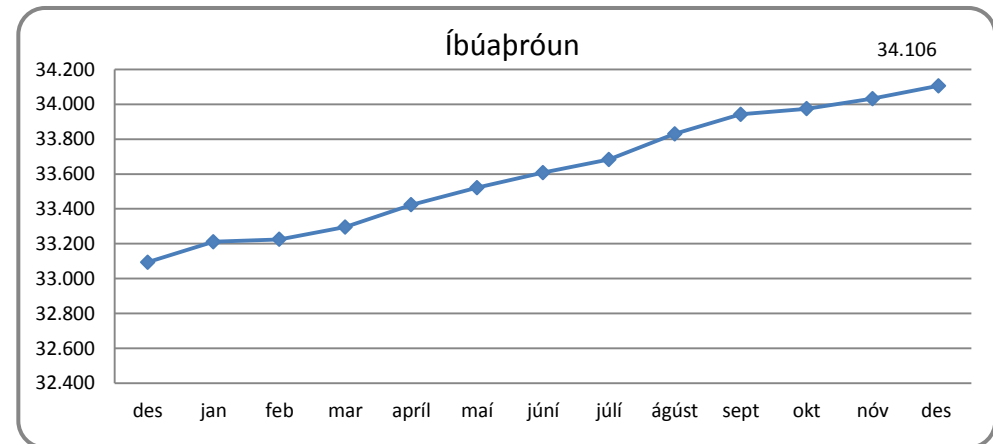
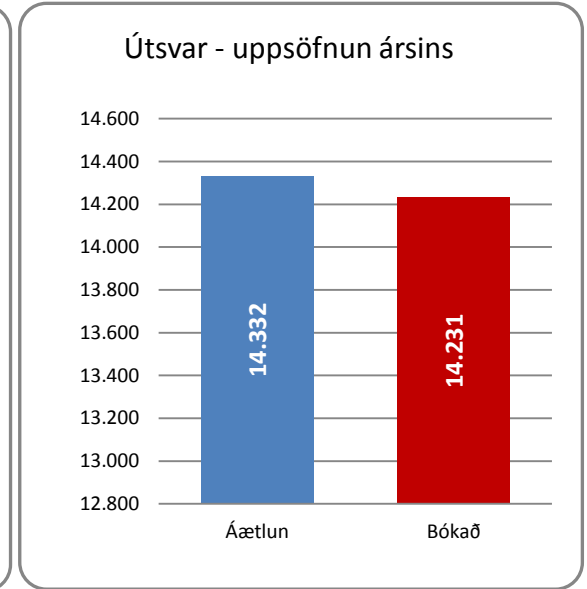
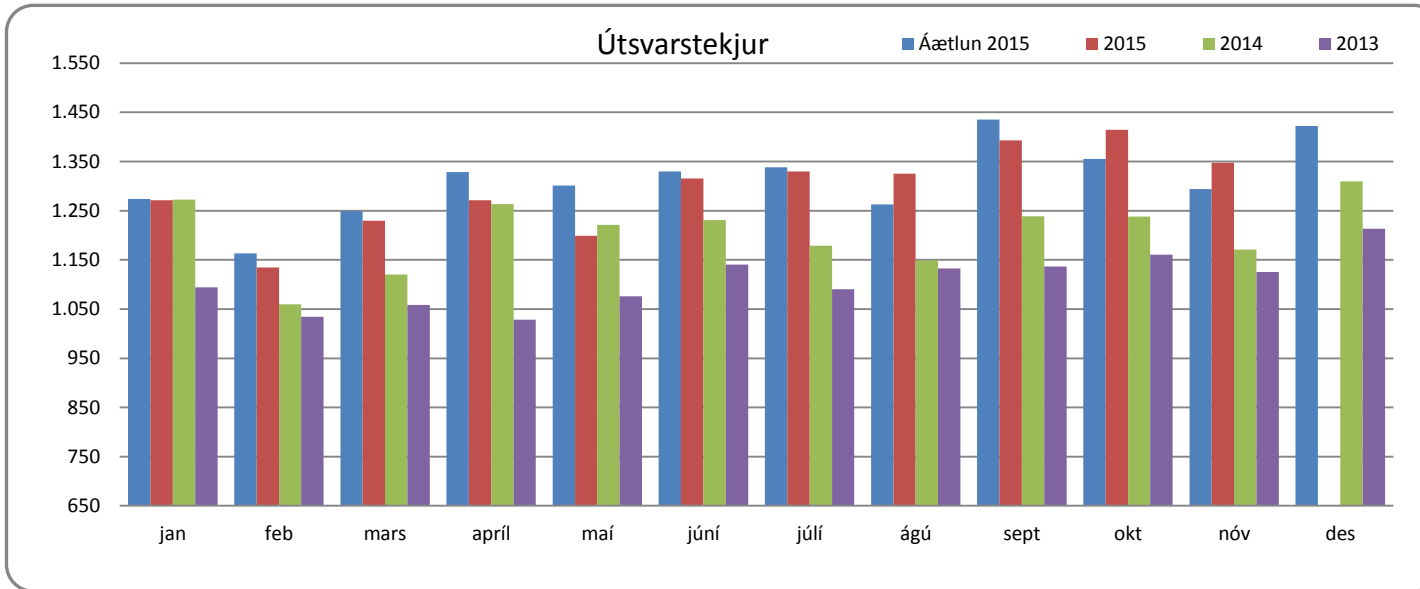
Dimmuhvarf í Kópavogi, heimili fyrir sex fatlaða einstaklinga, var vígt formlega við hátíðlega viðhöfn 16. nóvember. Kópavogsbær tók við húsnæðinu þegar málaflokkurinn var fluttur til sveitarfélagsins en nú var ráðist í gagngerar endurbætur á húsnæði auk þess sem skipulagi íbúðanna var breytt, betur gætt að sjálfstæði íbúa en sameiginlegt rými minnkað.

Veðrið lék við Kópavogsbúa sem fjölmenntu á aðventuhátíð bæjarins. Venju samkvæmt var tendrað á jólatréi daginn fyrir fyrsta sunnudag í aðventu, leikin var tónlist og slegið upp jólaballi. Hátíðin var að þessu sinni á nýjum stað, á túninu við menningarhúsin í Kópavogi sem buðu upp á dagskrá alla helgina í tengslum við aðventuhátíðina.

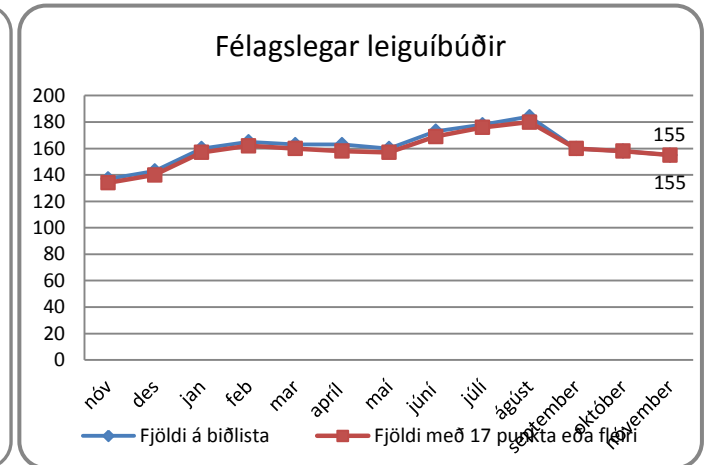
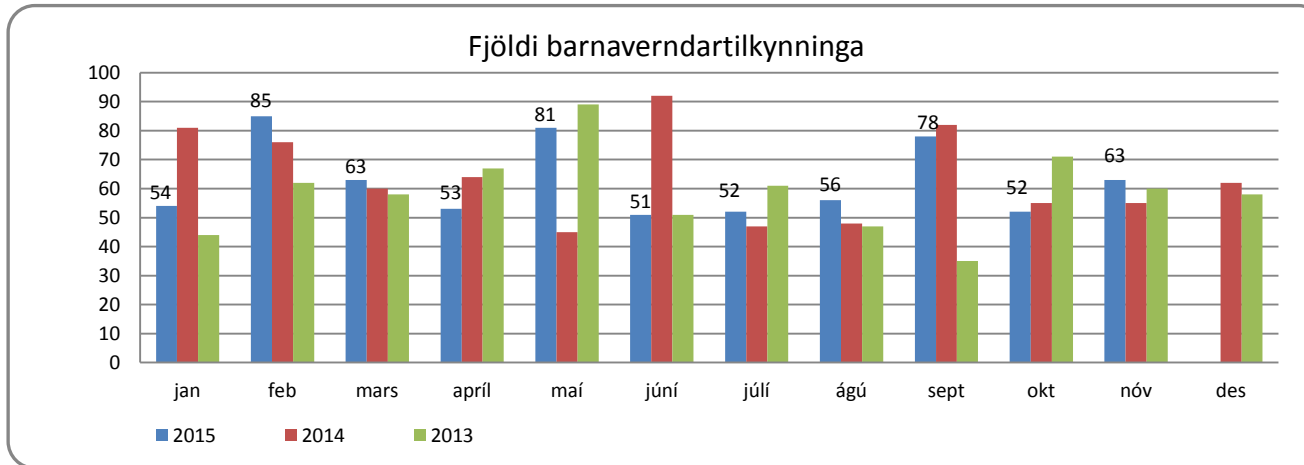
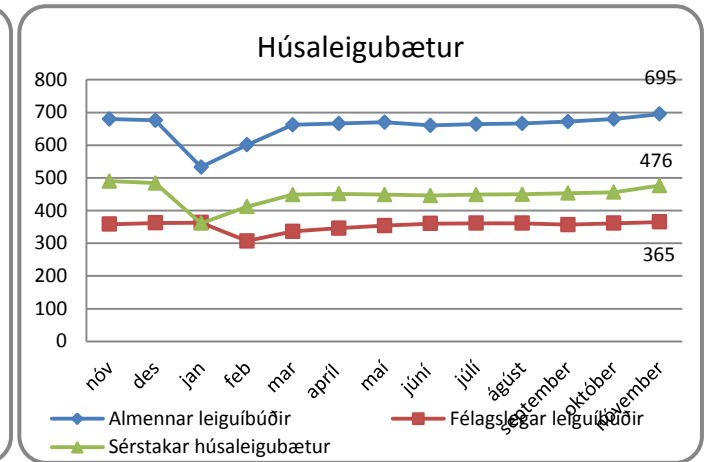
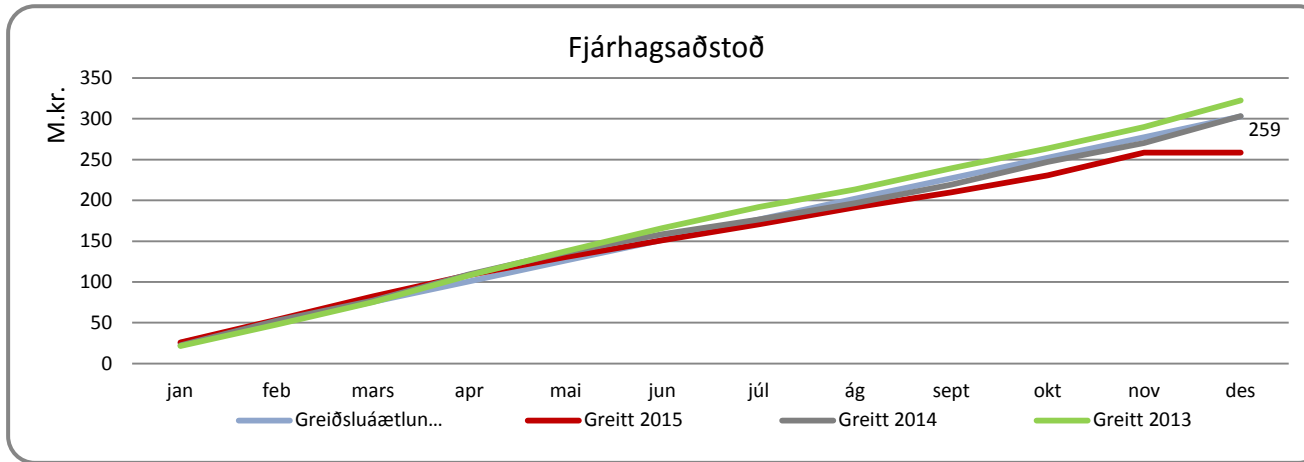
Fjárhagsáætlun Kópavogs fyrir árið 2016, sem gerð var í samvinnu allra bæjarfulltrúa, var samþykkt með öllum greiddum atkvæðum á fundi bæjarstjórnar 24. nóvember. Í áætluninni kemur meðal annars fram að skuldahlutfall bæjarins lækkar umtalsvert á næsta ári, samstæðan verður rekin með 257 milljón króna rekstrarafgangi, fasteignaskattar lækka og útsvar verður áfram undir leyfilegu hámarki.

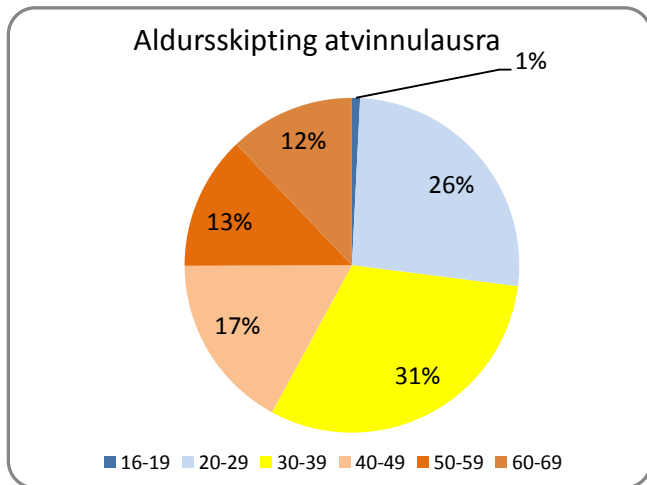
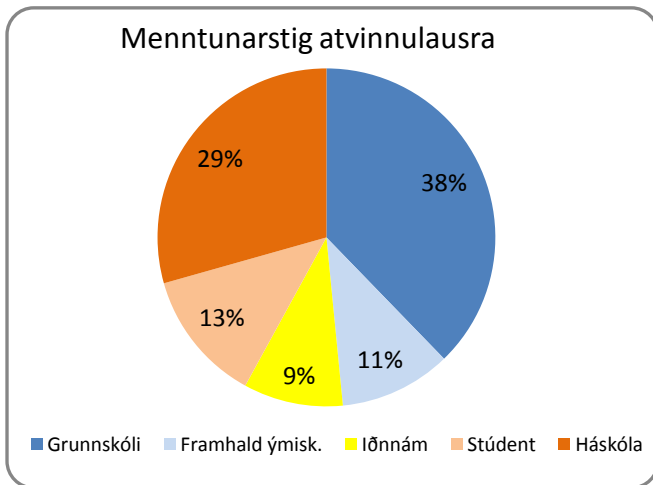
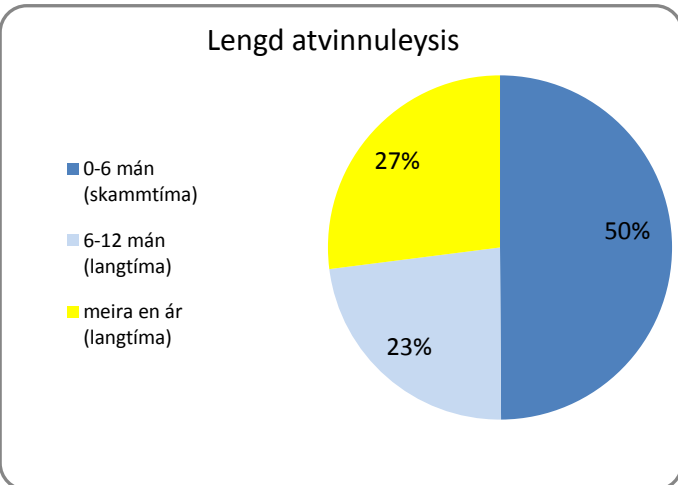
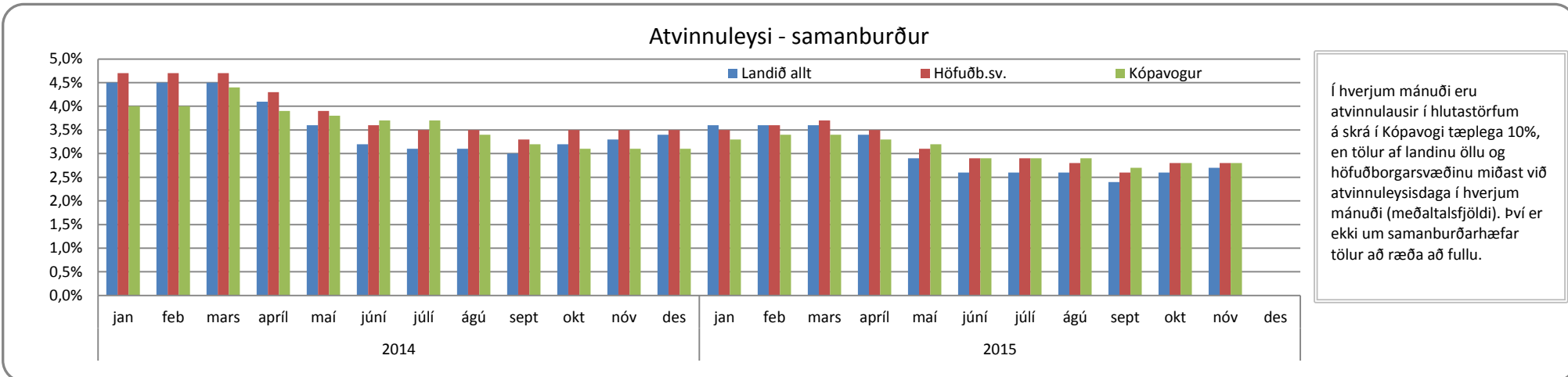
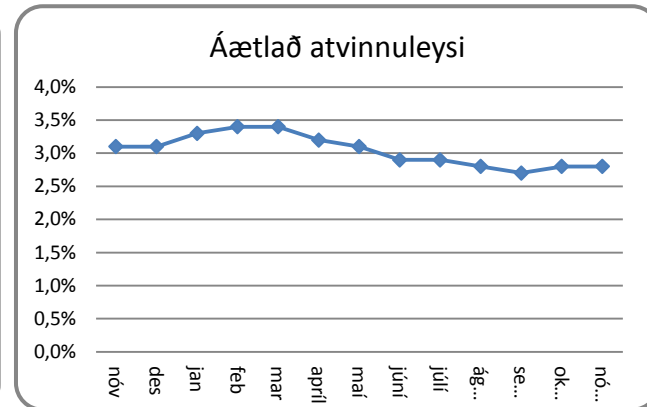
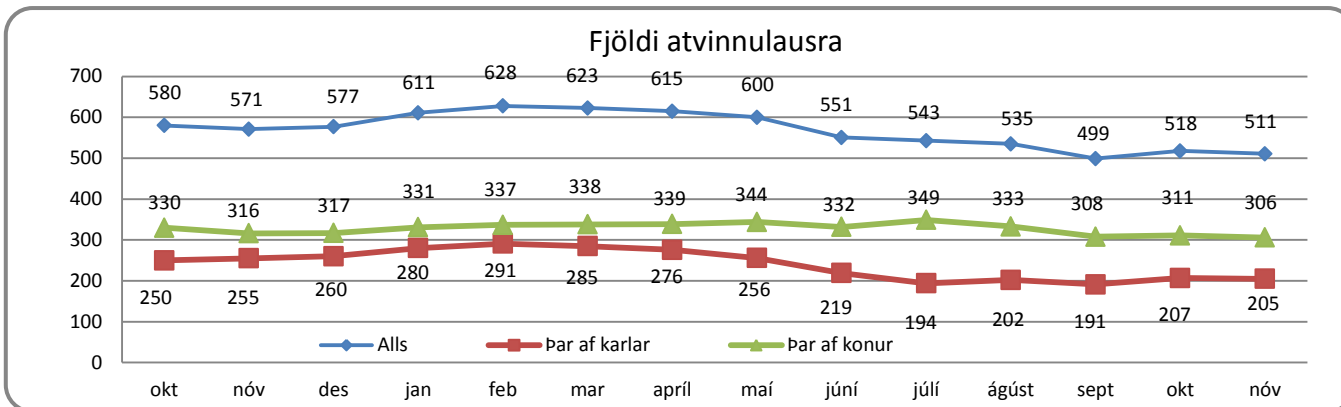
